# ABSENTEE VOTING -

# You are Required to Wear a Mask/Face Covering and Maintain 6 Feet of Distance When Entering any Board of Elections Facility.

Primary Elections are held so that voters registered with a qualified political party may select their party's nominees to the general election for partisan offices. Because a primary is a party election, only voters registered with one of the parties qualified to conduct a primary in New York City may vote in their party's primary.

General Elections are held to elect candidates to public offices. For partisan offices, nominees from the party primary elections appear on the ballot, along with independent candidates.

# **Getting an Absentee Ballot**

All registered voters should receive an absentee ballot application by mail automatically, per the governor's order. But if a voter does not receive one -- or to be more sure to get one --, there are other ways to apply for an absentee ballot with the New York City Board of Elections, the simplest being to apply via the board's website.

Registered voters can also email or fax applications to the board (<u>AbsenteeJune2020@boe.nyc</u>; 212-487-5349), mail one to a local borough office, or call the BOE's hotline: 1-866-VOTE-NYC.

The deadline to apply for a ballot in person is June 22, but the other options require applications to be submitted by June 16.

If all goes well, absentee ballot applications arrive with a prepaid return envelope.

### Under the Governor's Executive Orders:

To help prevent the community spread of COVID-19, all registered, eligible voters may apply to vote by Absentee ballot for the June 23, 2020 elections. Voters affected by COVID-19 including the risk of contracting the virus, should check the box "Temporary Illness" as the reason for requesting an Absentee Ballot. The definition has been temporarily expanded to include those affected by COVID-19 and/or the potential of contracting the virus.

### When is it due?

You must postmark, apply online, email or fax completed application for the Primary Absentee ballot by **June 16**, **2020**. You may apply in-person by **June 22**, **2020**.

Ballots will be mailed beginning on/after **May 8, 2020**. If you do **not** have a primary in your district, you will **not** receive a ballot.

# **Qualifications to Vote by Absentee Ballot**

- Absent from New York City on Election Day.
- Unable to appear at the polls due to temporary or permanent illness or disability; or because you are the primary care giver of one or more individuals who are ill or physically disabled.
- A patient or inmate in a Veterans' Administration Hospital.
- Detained in jail awaiting Grand Jury action or confined in prison after conviction for an offense other than a felony.
- An individual convicted of a Felony and on probation. However, you cannot vote after convicted of a Felony and imprisoned or on parole.

\*The definition of "Temporary Illness" has been temporarily expanded to include those affected by COVID-19 and/or the potential of contracting the virus to prevent community spread, by Executive Order of the Governor.

## **In-Person Absentee Voting**

Absentee voting in person begins as soon as the ballots are available and ends on Election Day.

Absentee ballots can be cast at the <u>Board of Elections</u> office in your borough from 10:00 AM -4:00PM, Monday through Friday. For the upcoming June Primary elections,

On Election Day, absentee ballots can be cast until 9:00 PM.

**Emergency Absentee Ballots** 

If the deadline for requesting an absentee ballot by mail has passed and you cannot appear at the polls on Election Day because of an accident or sudden illness, then you may send a representative with an authorized letter to receive an Absentee Ballot Application and Absentee Ballot and return both to the Board of Elections by 9:00 PM on Election Day at your borough office.

Overseas and Military Voters

If you are applying for an absentee ballot because you or your family are in the military or because you currently reside overseas, do not use this application. You are entitled to special provisions if you apply using the Federal Postcard Application.
